SKOR North - 2024 Minnesota Golf Show \$100,000 Pontoon Putt Present by Nelson Marine Contest

Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE CONTEST, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. Eligibility The SKOR North 2024 Minnesota Golf Show \$100.000 Pontoon Putt Contest (the "Contest") is open to legal residents of Minnesota and Western Wisconsin, who are 18 years of age or older and WHO HAVE NOT PREVIOUSLY PARTICIPATED IN THIS CONTEST IN PREVIOUS YEARS. Void where prohibited by law. No purchase necessary to enter the Contest. Employees of MN Golf Show, Precision Events, LLC, KSTP-AM, LLC (collectively, the "Sponsor"), Nelson Marine (the "Promotional Participant"), American Hole in One, International Hole In One Association d/b/a Odds On Promotions, HBI Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Contest (collectively with Sponsor, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. Any current or former professional golfer as defined by USGA guidelines (PGA, LPGA or any other professional tour), any current or former club professional who has not achieved reinstatement to amateur status, any current NCAA, NAIA, or IUCO golfers or anyone who has played at any collegiate level within the past six (6) years are also not eligible to enter or win in this Contest. Further, if you have won or accepted a prize from SKOR North within the past thirty (30) days from the day of the Finalist putt (defined below), or won and accepted a prize or combination of prizes with a total state value of \$1,000 or more from SKOR North within 365 days from the day of the Finalist putt, you are also not eligible to enter or win this Contest. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. **Contest Period** The Contest begins at 10:00 AM Central Time ("CT") on February 9, 2024, and ends on February 11, 2024, at 1:00 PM Central Time ("CT") (the "Contest Period").
- 3. **How to Qualify for the Grand Prize Putt** To enter for a chance to qualify for the Grand Prize Putt event, visit the \$100,000 Pontoon Putt Presented by Nelson Marine Booth at the 2024 Minnesota Golf Show in Hall B at the Minneapolis Convention Center at 1301 2nd Avenue South, Minneapolis, MN 55403 (the "Show"), and pay \$5.00 for every 3 putts. Any eligible individual that successfully makes a putt from the designated Qualifier line, as solely determined by Sponsor (a "Qualifier putt"), will be deemed a Qualifier, and that Qualifier will be invited to come back to the Show on Sunday, February 11, 2024 at 1:00 PM CT for a chance to be selected as a Finalist and to putt to win the Grand Prize. A person can buy as many putts as he/she wishes, but only 1 successful putt made is required to become a Qualifier.
- 4. **The Grand Prize Putt Event –** Then, on Sunday, February 11, 2024 at 1:00 PM CT, each Qualifier will check in at the \$100,000 Pontoon Putt presented by Nelson Marine Booth at the Show. In order to be eligible to participate in the Grand Prize Putt event, each Qualifier must check in no later than 1:00 PM CT. Any Qualifier checking in after 1:00 PM CT will be disqualified and will not be eligible for the Grand Prize Putt event. At check in, each Qualifier must (1) present his or her drivers' license to provide he or she is eligible to participate, and (2) read and sign the Affidavit of Eligibility, Liability and Publicity Release AND the Contestant Agreement to Participate, prior to being allowed to attempt to make the Finalist putt. Decisions of judges are final in all matters relating to the Contest. Upon successfully checking in, Sponsor will randomly select the order in which the Qualifier's will attempt to make another putt to determine the Finalist (the "Finalist Round"). The Qualifier who makes the most

successful putts during the Finalist Round will be deemed the Finalist and he/she will have one (1) chance to putt for the Grand Prize on the Grand Prize green. For any putt to qualify, the golf ball must come to rest completely inside the cup. A ball that enters the cup but fails to remain inside the cup will **not** constitute a winning putt.

Eligible Grand Prize Putt Attempt Requirements

- No practice, warm-up or qualifying putts on the green being used for the Grand Prize putt will be allowed.
- The single putt attempt must be initiated from behind the demarcation line as specified by Sponsor. A foot fault (contestant's foot touching or crossing over the respective demarcation line) will disqualify any putt attempt. The Finalist will not be allowed another putt to replace the faulted putt.
- In order to be considered a successful putt attempt, the golf ball may not come in contact with or bounce off of any person, wall or object in any manner prior to entering the cup other than the surface of the putting green. A golf ball that contacts or bounces off of any person, wall or object prior to entering the cup is immediately disqualified regardless of the outcome of the putt attempt.
- In all circumstances, an eligible Finalist may have a maximum of one golf putt attempt regardless of the outcome of their initial Grand Prize putt attempt.
- The Finalist acknowledges and agrees that the Grand Prize Putt attempt will be videotaped by Sponsor, or a representative of Sponsor, which must be verified by Sponsors insurance company.
- A "putt" is defined as a "stroke" and a "stroke" is the forward movement of the club made with intention of fairly striking at and moving the ball.
- The Finalist will be allowed one (1) attempt to successfully hole a putt using a USGA approved golf ball, from a minimum distance of one hundred twenty (120) feet into a regulation four and one quarter (4 1/4) inch hold/cup.
- A ball is considered "holed" when it is at rest within the circumference of the hole and all of it is below the level of the lip of the hole.
- The eligibility of the putt is subject to the USGA rules of golf.
- The eligibility of the putt is subject to approval by Sponsor's insurance company.
- 5. **Prize and Approximate Retail Values ("ARV") One (1) Grand Prize –** Å 2024 Southbay 523RS 3.0 (triple tube) with a Mercury 200hp four stroke motor and \$13,000 cash. ARV: \$100,000 <u>OR</u> a straight cash option of \$25,000.00. ARV: \$25,000.00. In the event the Grand Prize winner selects the cash option, the winner will ONLY receive \$25,000 and will not receive the boat or the value of the boat and hereby waives his/her right to claim the boat as part of the prize upon selecting the cash option. All warranties and guarantees are subject to the manufacturers' warranties and guarantees.

A maximum of one (1) Grand Prize(s) will be awarded if there is a Grand Prize winner. Grand prize winner(s) must accept delivery of prize from Sponsor, or as otherwise instructed by Sponsor. - 6. **Claiming the Prize** The winner and Sponsor will work with one another to determine how the Grand Prize winner will receive his/her Grand Prize. The Grand Prize winner represents and warrants that he/she will make best efforts to assist Sponsor in coordinating how the winner will pick up or receive the Grand Prize within no more than 30 days from the date the potential winner is verified by Sponsor's insurance company.

Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made.
